World Day Plans are Heating Up!

Communities throughout the US are mounting activities to observe the 5th World Elder Abuse Awareness Day on June 15th. Plans include efforts to engage Americans of all ages as well as professionals. Every spring, the NCEA asks its readers to share news of events underway in their regions. Here are some examples of observances planned this year.

Illinois

In Illinois, the Cook County Sheriff's Office, in conjunction with the Area Agency on Aging (Age Options), is hosting a Suburban Police Chief's Round Table event on June 15, 2010 at the Sheriff's Police Training Academy.

The tentative schedule includes presentations by a State's Attorney, a police financial crimes unit commander, and an elder abuse supervisor. Other speakers will provide information on utilizing senior volunteers in local SALT councils and Triads, as well as police personnel encouraging all 130 suburban Cook County police departments to implement law enforcement protocols for responding to elder abuse.

According to Katie Walsh of the Cook County Sheriff's Department who provided this information, "The goal is to have one representative from each of the 130 municipalities in Suburban Cook County attend this World Elder Abuse Awareness Day program." For questions, [Click Here](#).

Minnesota

Kevin Hansen, ombudsman specialist, provided the following update:

"[The Center for Elder Justice and Policy](#) (at William Mitchell College of Law), the Department of Human Services Adult Protection Division, and the Ombudsman Office for Mental Health and Developmental Disabilities have teamed up to hold our second annual WEAAD event at William Mitchell College of Law in St. Paul, MN. Last year we had an event with various speakers presenting on issues related to vulnerable adults and elders, along with relevant legislative updates. This year the event is expanding to include plenary sessions in the auditorium along with four breakout sessions throughout the day. The title for our event this year is ***World Elder Abuse Awareness Day: Connecting the Dots to Protect Elders and Vulnerable Adults.***

"Topics which will be presented include:

- Financial Exploitation of Vulnerable Adults
- Alzheimer's Disease and the Effects of Dementia
- Capacity vs. Competency
- Elder Abuse Prosecution
- Preventing Elder Sexual Violence
- Communication Techniques for Elders with Dementia
- Law Enforcement Investigations of Vulnerable Adult Maltreatment
- Understanding Substitute Decision-Making (Guardianships, Conservatorships, Health Care Directives, Powers of Attorney)
- Recognizing and Helping Unbefriended Elders
- Frauds and Scams Toward Vulnerable Adults

- Ombudsman 101
- Serving Individuals with Multiple Disorders.

“The day will conclude with a legislative update highlighting important changes from both the Minnesota legislature and the United States Congress, especially as it relates to the Elder Justice Act and pertinent provisions. We also will have sponsors for the day tabling in the main auditorium with information about their programs and services, and participants will have the ability to ask questions and also take materials home if they wish to do so.” For questions, [Click Here](#).

Missouri

Marta Fontaine, elder abuse prevention planner and legal services developer, submitted the following:

“Last year I had visited one of the local senior centers on June 15th. I was dismayed to learn that no one was able to tell me what elder abuse was. And, even more disconcerting was the fact that most didn’t even realize that we had a toll-free hotline to report elder abuse (the hotline was established in 1987).

“So, this year we are developing a very brief (15 minute) talk on Elder Abuse and How to Report It. The frontline APS workers can present this at their local senior center on that day. The AAAs can help us get the word to the senior centers that this will be made available and will be distributing WEAAD posters designed by our department staff. The poster encourages people to show their support by wearing purple.” For questions, [Click Here](#).

New York

Jenny Hicks, social worker and elder abuse educator at [Vera House, Inc.](#) in Syracuse, provided NCEA with details on the area’s Intergenerational Art Project:

“In conjunction with World Elder Abuse Awareness Day, the Elder Abuse Committee of the Syracuse

Area Domestic & Sexual Violence Coalition is coordinating an intergenerational art project with local agencies and schools in an effort to show our appreciation of Older Americans. The project aims to promote a positive alternative message to the negative stereotypes about aging and the importance of ending elder abuse. Children and young people are encouraged to produce artwork which shares a positive message about older people in their lives, whether they be grandparents, friends, or others.

“We have been collaborating with several schools in our county, a foster grandparent program, the Salvation Army, a pen pal program that pairs children with older individuals, and a local community arts coalition. In particular, we targeted organizations that had already established intergenerational initiatives. We hope to continue the project next year as well.

“All artwork created will be displayed at the local World Elder Abuse Awareness Day Event, which will be held on June 15th, 2010 from 10:30 to 11:30, at the Salina Civic Center, 2826 LeMoyne Ave., in Syracuse.” For questions, [Click Here](#).

Color Our World Purple on June 15th!

When the first World Elder Abuse Awareness Day was established in 2006, the [International Network for the Prevention of Elder Abuse](#) selected purple as WEAAD's official color. The NCEA is encouraging everyone to wear purple on June 15th as a visible demonstration of support.

Last year, psychologist and advocate Nora J. Baladerian shared the following with NCEA:

“How about wearing purple for World Elder Abuse Awareness Day in solidarity with all the known and unknown victims to stand proudly, regally in their honor? Can you see the photo? Millions of people wearing purple. Easy. Free. Powerful.”

Colorful logos and symbols are powerful tools in raising awareness of an issue, which is always the first step in prevention. Perhaps the most successful adaptation of this concept is the breast cancer awareness pink ribbon motif which has been applied to everything from pink ribbon lapel pins to pink ribbon cookies, and has become one of the most recognizable icons in our society.

During 2009, many aging services agencies encouraged members and their clients to wear purple on World Day. Notices appeared on websites and in newsletters to spread the word. Groups used purple balloons and decorated public spaces with purple ribbons to make a colorful statement. This is a very easy and cost effective method of participating in World Day observances. Here are some ideas for how we can use the color purple to raise awareness this June:

- Wear purple clothes, jewelry, or accessories.
- Wear and distribute purple Mardi Gras beads; you may want to approach your local party supply stores to see if they can donate or discount supplies to aid in the cause.

- Involve your local schools or youth clubs to make purple ribbons, and hand them out at super markets, places of worship, public buildings, etc. (Hint: High school students are always looking for creative and interesting ways to rack up community service hours, and this would be an excellent introduction to engage them in elder abuse awareness.) Or, as aging services professional Janet Lamb reports they did in Tennessee, work with senior centers to create and distribute purple ribbons.
- String violet holiday lights around windows and door frames.
- Decorate with baskets or bouquets of iris, violets, and other purple flowers or plants.
- Display a giant jar filled with purple jelly beans and invite people to guess how many there are.
- Use purple background for emails, or highlight or compose in purple.

The NCEA recognizes that worker safety is a priority for all APS organizations and others who respond to cases of elder abuse. This webcast is the second in a series to focus on personal safety issues that social workers face on a regular basis including: how to deal with and exit potentially violent situations; safety planning in the office; safety planning for home visits, and practical self-defense.

The featured presenter is Janet Nelson, who combines 35 years of training and teaching in the martial arts with her experience as a clinical practitioner and has developed a unique approach to personal safety awareness that stresses mind-body training, professional awareness, and psychosocial issues. She began her martial arts training in 1974 and has earned a black belt. A graduate of the University of Florida (BA) and Florida State University (MSW), Ms. Nelson began her social work career in 1978 and is a member of the National Association of Social Workers' Academy of Certified Social Workers (ACSW). She is also a Florida-Licensed Clinical Social Worker (LCSW) in private practice. Since 1980, Ms. Nelson has conducted seminars and short courses on personal

safety across Florida and the nation. After teaching women's self-defense courses for many years, she created Everyday Self Defensesm, a unique approach to personal safety that draws upon her diverse training.

The Brooke Astor Trial: A Case Study

In late December, Anthony Marshall, the only son of the late Brooke Russell Astor, and Francis X. Morrissey, an attorney, were both sentenced to a state prison term of one to three years for defrauding and stealing from the legendary philanthropist. Although the trial involved an extremely high profile victim and the loss of millions of dollars, the case exemplified many aspects typical of elder financial exploitation cases. Because of these similarities, the Astor trial provides a valuable case study for prosecutors and other legal practitioners, APS, and various professionals involved in criminal investigation and prosecution of elder abuse.

The webcast will feature New York County Assistant District Attorney (ADA) Elizabeth Loewy who initiated the Astor investigation and served on the trial team. ADA Loewy will highlight prominent features of the case and respond to questions submitted in advance relating to case preparation and prosecution. She will also discuss the function of the Office's specialized Elder Abuse Unit, of which she is the attorney in charge.

Spotlight on New Videos

Recent Releases by Terra Nova Films

[Terra Nova Films](#) is a distributor and producer of films dealing with diverse issues related to aging, including the various forms of elder abuse and neglect. Here are descriptions of two recent releases:

Self-Neglect: What We Can Learn From the Mary Northern Case

This video documents the story of Mary Northern and examines its relevance for aging services. Mary Northern was a self-neglecting older individual living in Nashville, Tennessee, who in the winter of 1978 was brought to the hospital with a gangrenous foot. She refused treatment, sparking guardianship proceedings, as well as legal action to initiate medical intervention. The video presents a panel of speakers from the medical, APS, mental health, and legal fields who offer their perspectives on the issues raised by the case. Issues examined include mental capacity, the importance of documentation, as well as the importance of service coordination. The film is co-produced by Terra Nova films and the National Committee for the Prevention of Elder Abuse. (Run time: 99 minutes.)

A Mother Never Gives Up Hope: Older Mothers and Abusive Adult Sons

This video presents the stories of four older women who had been abused by their adult sons. The individuals describe their stories, touching on the emotions felt, as well as how they dealt with the abuse. The women are followed over the course of two years to see how their relationships with their sons have evolved. Included with the film is a

training guide with discussion questions for use by advocates and group facilitators working with older women. The film is co-produced by Terra Nova Films and the National Clearinghouse on Abuse in Later Life. (Run time: 42 minutes.)

The three webchat panelists were Kathy Greenlee, Assistant Secretary for Aging, U.S. Department of Health & Human Services, Jonathan Blum, Deputy Administrator and Director, Center for Medicare, Centers for Medicare & Medicaid Services, U.S. Department of Health & Human Services, and AARP President Jennie Chin Hansen. 1. National Aging Information & Referral Support Center

To support the Aging Network's efforts to provide quality information, referral and assistance services to older people and their caregivers, AoA has funded the National Aging Information and Referral Support Center since 1991. The Support Center provides training, technical assistance, product development and consultation to State Units on Aging and Area Agencies on Aging, information, referral and assistance programs, and Aging and Disability Resource Centers and assists them in strengthening their programs. The Support Center has played a significant role in the evolution and advancement of aging I&R/A.

2. Lifespan Respite Care Program

“The US Administration on Aging (AoA) is providing this competitive grants opportunity to eligible state agencies for implementing the requirements of the Lifespan Respite Care Act of 2006 (P.L. 109-716). Lifespan Respite Care programs are coordinated systems of accessible, community-based respite care services for family caregivers of children or adults of all ages with special needs. AoA plans to fund approximately 10-15 grants under this Announcement, with a federal funding level of up to \$200,000 per award for a 36 month project period. Eligible state agencies funded under this announcement shall use grant funds for the purposes of planning, establishing and expanding/enhancing Lifespan Respite Care systems in the states, including new and planned emergency respite services, training and recruiting respite workers and volunteers and assisting caregivers with gaining access to needed services. Eligible recipients of respite services under this Program Announcement include family members, foster parents, or other adults providing unpaid care to adults who require care to meet basic needs or prevent injury and to children who require care beyond that required to meet the basic needs of the child.”

US Department of Agriculture

1. Supplemental Nutrition Assistance Program (SNAP) - Increasing SNAP Participation among Medicare’s Extra Help Population

USDA's Food and Nutrition Service is soliciting applications for pilot projects to encourage eligible elders to participate in SNAP:

"SNAP helps low-income families purchase healthy foods and maintain nutritious diets. Even though

the number of people receiving SNAP has increased dramatically in recent years, the percentage of eligible elderly individuals who participate in SNAP remains low....Although 7 million elderly individuals are eligible for SNAP, only 2.2 million participated in SNAP...."

US Department of Justice

1. Coordinated Tribal Assistance Solicitation

"DOJ developed this Coordinated Tribal Assistance Solicitation (CTAS) for Fiscal Year (FY) 2010, combining DOJ’s existing Tribal government-specific competitive solicitations into one, and thus requiring only one application from each Tribe or Tribal consortium. This approach provides federally-recognized Tribes and Tribal consortia the opportunity to develop a comprehensive approach to public safety and victimization issues.

"DOJ’s Tribal government-specific competitive grant programs outlined in this Coordinated Tribal Assistance Solicitation are referred to as 'Purpose Areas.' Each Tribe should select the Purpose Areas that best address its public safety, criminal and juvenile justice, and victimization issues. In response to a single Tribal or Tribal consortium application requesting funds from multiple Purpose Areas, multiple awards may be made...."

Purpose Area #7: Provide community outreach and victim assistance services to address elder abuse (OVC—Tribal Elder Outreach Program – TEOP)

2. Research and Evaluation on Sexual Violence, Stalking, and Teen Dating Violence

“Research and Evaluation on Sexual Violence:

Sexual violence is one of the most underreported crimes in the United States and includes a wide range of unwanted behaviors that are attempted or completed against a victim's will or when a victim cannot consent because of age, disability, or the influence of alcohol or drugs. Sexual assault can have devastating effects that can last a lifetime. According to the National Violence Against Women Survey, 1 in 6 American women has been the victim of a completed or attempted sexual assault during her lifetime. In addition to the immediate trauma, victims face the risk of sexually transmitted diseases and pregnancy. Long-term mental health effects can include depression, anxiety, and post-traumatic stress disorder, yet many victims do not report.”

Note: The National Institute of Justice is particularly interested in research on underserved populations; however, older victims were not specifically identified as a target population.

Federal Legislative Update

A Quarterly Look at Legislation that May Impact the Lives of Older Americans:

- The *Patient Protection and Affordable Care Act* ([H.R.3590](#)) became public law on March 23, 2010. Included in the law are the *Elder Justice Act* and the *Patient Safety and Abuse Prevention*

Act. Major provisions of the Elder Justice Act allow for federal funding of APS and Long Term Care Ombudsman programs and the establishment of an Elder Justice Coordinating Council. The major provision of the Patient Safety and Abuse Prevention Act creates a national criminal background check for persons applying for employment at long-term care facilities.

- The ***National Silver Alert Act*** ([S.557](#)) recently gained the support of four additional co-sponsors: Senators Russell Feingold (D, WI), Blanche Lincoln (D, AR), Mark Pryor (D, AR), and Sheldon Whitehouse (D, RI). The stated purpose of the bill is to "...encourage, enhance, and integrate Silver Alert plans throughout the United States, to authorize grants for the assistance of organizations to find missing adults, and for other purposes." There are now eleven co-sponsors.
- The ***Senior Investment Protection Act*** of 2009 ([H.R.3551](#)) "Directs the Attorney General to establish a program of grants to states to: (1) investigate and prosecute misleading and fraudulent marketing practices; or (2) develop educational materials and training aimed at reducing misleading and fraudulent marketing of financial products toward seniors." In addition to six co-sponsors, the bill was co-sponsored by Representative Paul Tonko (D, NY-21) on January 27, 2010. Earlier that month, Representative Tonko also co-sponsored The ***Senior Investor Protections Enhancement Act of 2009*** ([H.R.3550](#)), which seeks "To enhance penalties for violations of securities protections that involve targeting seniors." The bill now has four co-sponsors.
- The ***Guaranteed 3% COLA for Seniors Act of 2009*** ([H.R.4193](#)) seeks "To require the establishment of a Consumer Price Index for Elderly Consumers to compute cost-of-living increases for Social Security benefits under title II of the Social Security Act and to provide, in the case of elderly beneficiaries under such title, for

an annual cost-of-living increase which is not less than 3 percent." The bill, introduced by Representative Eliot Engel (D, NY-17) with no co-sponsors, was referred from the House Education and Labor Committee to the Subcommittee on Health, Employment, Labor, and Pensions on January 4, 2010.

13th Annual Kern County Elder Abuse Prevention Conference: Undue Influence Tactics of Abuse
